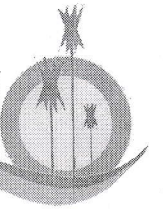




1. Complete the work within stipulated time as per mentioned in Work Order.
